1. Items in new & like new conditions will be accepted. Items chosen will be selected based on condition, style, fashion, season, on trend, demand, store capacity, & is at the discretion of Wish Upon a Star Consignment.
 - a. Items must be brought in a tote or laundry basket, no plastic bags (items in plastic bags will be refused).
 - b. Consignors may bring up to 15 items every 21 days for consignment.
 - c. All clothing items must be freshly laundered. No wrinkles, stains, fading, pilling, holes, lint, pet hair, missing buttons, or odor, etc.
 - d. Consignor represents & warrants that they are the sole owner of the item/s on consignment & that ALL items have been checked for recalls & have NOT been deemed hazardous by the US Consumer Product Safety Commission. Consignor agrees to indemnify and hold Wish Upon a Star Consignment owner harmless should any claims be filed resulting from recalled items.
 - e. Items/equipment must be clean, complete & have working batteries (if applicable).
 - f. If an item is accepted for consignment & upon further inspection is found to have a stain, hole, or defect we will dispose of or donate the item if the retail value is \$30 or under.
 - g. Wish Upon a Star is not responsible for loss or damage to items. Including, but not limited to; damage caused by theft, fire, flood, pandemics, national emergencies, government shutdowns, any type of stains, tears, loss, & any other damages or losses without exclusion.
 - h. **Items not accepted for consignment include, but are not limited to: Large Furniture, Business Attire, Dress Pants, Formal Dresses/Gowns, Shein, any Walmart brands (i.e. Faded Glory, George, etc.)

2. Consignment Period and Earnings
 - a. Consignment period is 60 days.
 - b. Wish Upon a Star determines acceptability of items and its corresponding selling price as well as price reductions during consignment period.
 - c. Consignor receives 40% of the final sale price, minus taxes, for all consigned items. For handmade items, consignor earns 75%.
 - d. Consignor payouts will be via cash or store credit.
 - e. It is the consignors responsibility to keep up with their account. If payouts are not picked up after 6 months, monies will be forfeited. We DO NOT contact you for reminders.
 - f. Consignor will have 1 - 5 days prior to the end of the 60 day consignment period to pick up any unsold items they would like back. We DO NOT contact you for reminders. We DO NOT have the staff to help you look for your items, that will be the sole responsibility of the consignor.
 - g. Items left after the 60 day consignment period become the sole property of Wish Upon a Star & will be donated or sold at the discretion of Wish Upon a Star.
